The Gharinda police have arrested a private school teacher for allegedly raping a four-year-old girl student. A woman helper of the school was also held in the case.

The accused have been identified as Ashwani Kumar and Kanwal. A case under Section 376 and 201 of the IPC and Section 4 of

Protection Of Children from Sexual Offence (POCSO) Act has been registered against them.

The incident came to light when the victim complained of pain in her private parts after returning from school on Thursday. The victim, along with her 10-year-old elder sister, studies at a private school in Nesh-ta, located near the International Border.

Rape accused commits suicide in Muktsar jail

A teacher in his early-fifties, who was booked for allegedly raping a student about three months ago, committed suicide by hanging himself with a ceiling fan at the district jail here on Saturday.

The deceased, Tarlochan Singh, was a resident of Muktsar town and a teacher at a private school at Rahurian-wal village near here.

The jail staff has recovered

a suicide note from the deceased. Though nobody gave the details of this note, the staff said the deceased had not blamed anyone from the jail for taking the extreme step.

Meanwhile, Kulwant Singh, brother-in-law of the deceased, met Muktsar SSP Manjit Singh Dhesi on Saturday and demanded that the girl, who had lodged the 'false' complaint against the deceased, and her family should be booked.
